Chairman O'Rourke has been active in Yurok traditional ceremonies and gathering practices all of his life. He was part of the revitalization of the Pecwan Jump Dance, a dance that holds the roles fire owner and sweathouse leader. To this day, the Chairman continues to walk the ancient ceremonial paths, where he stops to sing traditional Yurok songs, many of which he has received from the spiritual realm, at special locations to bring balance back into this world.

He is currently in his third term to office of the Chairman and will serve until 2018. He previously served as Chairman 2009-2012 and 2012-2015. Vice-Chairman from 2003-2006. As Chairman, he is the Chief Executive Officer of the Tribe. Part of his duties include: presiding over all meetings of the Tribal Council and the Tribal Voting Membership, and acting as the principal spokesman and representative for the Yurok Tribe. Under his leadership, the Tribe has reclaimed tens of thousands of acres in Yurok ancestral territory, secured much needed water for the Klamath River and initiated a far-ranging jobs plan that will benefit Yuroks for generations to come. Before speaking to important issues the deeply reverent man prays for guidance from the Creator, as his ancestors have done since time-immemorial. He attributes the Tribe's continued success to the professionalism of his staff and the resiliency of Yurok people.
